Kaiser Permanente Board Chairman and Chief

Executive Officer Bernard J. Tyson was awarded "Executive of the Year" for his 30 years of service at one of the nation's leading health care providers. California State Senator Holly Mitchell and Los Angeles County Supervisor Hilda Solis each received the Public Service Award for their tireless efforts to ensure underserved communities receive their share of federal, state and county services.

Los Angeles City Council President Herb Wesson was the Master of Ceremonies

and also introduced a few of the award presenters and speakers. The evening not only recognized individual and corporate accomplishments, it also served as an update on business development and community engagement. Los

Angeles World Airports Chief Operations Officer Samson Mengistu spoke about the multimillion-dollar expansion plans currently underway at LAX. Los Angeles County Supervisor and Metropolitan Transportation Authority Board member Mark Ridley-Thomas gave remarks on issues facing the L.A. County Board of Supervisors and Metro.

Recently, our advocacy efforts on behalf of minority and disadvantaged businesses were instrumental in amending Los Angeles World Airports' (LAWA) Local and Local Small Business Enterprise Program Ordinance to include Local-State Disabled Veterans Business Enterprises (SDVBE) for contracts over \$150,000. LAWA has also instituted an Edge4Vets program to prepare military veterans to become a part of the airport workforce. Both these programs will provide an

GLAAACC EDUCATION FUND & FOUNDATION SCHOLARSHIP LUNCHEON

The 18th Annual GLAAACC Education Fund and Foundation Scholarship Luncheon was held on June 15 at the LA Hotel Downtown. The afternoon's theme, "Superstars of Success," fit the occasion as eight college-bound seniors from Crenshaw, Dorsey, George Washington Preparatory, and Jordan High Schools were awarded with scholarships ranging from \$3,000 to \$6,000 to propel them into the next chapter of their bright futures.

GLAAACC Ed Fund Chairman David Ford emphasized the organization's commitment to future business leaders. "We must channel our energy into building a population of successful business leaders to create a better community for us all," said Ford.

This year's keynote speaker was Daniel Armstrong, the founder of the mentorship program, *Find a Tree*, founding chairman of the Coalition for a Free South Africa and a Ford Foundation Fellow. This dream coach, motivational speaker and published author delivered an inspiring keynote address in which he encouraged students to pursue their goals even if they have to "find a tree and start there" to bring their greatest dreams to fruition.

Each of the scholarship recipients demonstrated relentless pursuit of their educational aspirations. Sindel Donaldson, who began searching for computer science internships during her sophomore year of high school, hopes that she will "one day be able to look into the face of a young, poor African American girl and say, 'Yes, it is possible to reach greater heights, and I am living proof of that."

SPOTLIGHT ON GLAAACC MEMBER: CHRISTINE KEITH, ELITE AUTO NETWORK



Christine Keith knows how to seize an opportunity and make the most of it. Five years ago, the former general practice physician became actively involved in her husband Todd's auto brokerage business, Elite Auto Network, which he started while still a student at California State University, Northridge.

"I did a lot of research and saw that this was a niche other auto brokers weren't fulfilling," she said. "I saw the opportunity and potential for our company to grow."

She decided to develop a commercial division to handle the transportation needs of large company accounts. Now, in addition to obtaining cars for individuals, Elite Auto Network has a commercial division which provides fleet management, vehicle procurement and passenger transportation services, such as shuttles, chartered vans and chartered buses for corporate clients. As Elite's president, Christine is responsible for managing the commercial division, while Todd maintains the personal vehicle procurement side of the company.

Most of Elite's clients come from referrals and word of mouth. However, Christine also seeks new commercial business through networking, responding to RFPs, attending conferences, being a certified minority business and being registered with supplier diversity portals. All these connections help Christine stay ahead of the competition.

Elite Auto Network's first corporate client was the Southern California Gas Company. The utility company giant was replacing pipelines underneath the El Monte train station and required a transportation company to shuttle displaced train passengers to and from the station's parking structure.

Davey Tree Expert Company is currently the company's largest client. The nationwide landscaping company needed a fleet of durable pick-up and utility trucks. Elite procured over 80 trucks for Davey's operations in California and Arizona. Davey found Elite Auto Network through its certification with the Southern California Minority Development Council.

Elite was recently awarded a contract to provide plug-in electric vehicles to the management staff at Los Angeles County Metropolitan Transportation Authority (Metro).

In addition to the variety of services Elite Auto Network offers, Christine credits the 30-year old company's success and longevity to its customized business approach. "We focus on how the vehicle will be used, the individual's lifestyle or the company's culture," she said. "We try to accommodate what the customer really needs."

Christine credits her trusted mentor Ron Williams at the Gas Company for her GLAAACC membership. She mentioned to him that she was seeking an organization where she could really get involved and participate when he recommended she join GLAAACC. "When Ron suggested I join GLAAACC, I immediately became a member."

GLAAACC ADVOCATES FOR DISABLED VETERANS BUSINESS INCLUSION

Thanks to the efforts of GLAAACC Chairman Gene Hale, Los Angeles World Airports (LAWA) Executive Director Deborah Flint, and Los Angeles City Council Herb Wesson, contracts over \$150,000 will now include a hiring goal for Local-State Disabled Veterans Business Enterprises (SDVBE).

The original ordinance established a Local and Local Small Business Enterprise Program for LAWA's procurement of goods, equipment and services exceeding \$150,000 but did not include a goal for SDVBE inclusion.

It was Hale who initially caught the oversight. While reviewing the original small business ordinance before it went to City Council for adoption, he noticed that there were no goals for SDVBE's inclusion in LAWA contracts.

"The fact that it didn't have a goal for veterans at all was pretty glaring to me," said Hale. "That was a big deal."

He immediately brought it to the attention of Wesson and Flint who promised to amend the ordinance. In March, the City Council passed the amended ordinance to include a SDVBE contracting goal.

In the following excerpt from the amended ordinance, the value of disabled veterans and their businesses is acknowledged:

"Disabled Veterans Business Enterprise Programs serve the purpose of rewarding veterans for their sacrifice of military service,

encouraging patriotic service among civilians, helping to ease the transition from military service to civilian life, and attracting loyal and well-disciplined people to government contracting opportunities. Disabled Veterans Business Enterprise recognize and utilize skills unique to veterans to encourage business success; promoting job creation and income for local employees; and increasing business tax revenue."

Bids or proposals that do not meet the Local Business, Local Small Business and/or SDVBE requirements established for that contract opportunity are subject to rejection for non-responsiveness.

In 2016, GLAAACC held a record number of mixers, workshops and seminars. 2017 is on track to be another unprecedented year for networking and educational opportunities.

"How to find the right investor for your business," was the topic for the first GLAAACC in the AM networking mixer. The panel included Kemar Newell, founder of Flip; angel investor Brian Horner; Austin Clements, Senior Associate at TenOneTen Ventures; and mergers and acquisitions expert Joe El Rady from UCLA Extension discussed a variety of business funding sources from angel investors to venture capitalists. Starlett Quarles, founder of Urban X Marketing and GLAAACC Board member, moderated this information-packed session. This event was hosted by UCLA Extension, who has partnered with GLAAACC to present relevant and educational workshops for GLAAACC members.

Our Spring Mixer highlighted Los Angeles World Aiports' multi-million construction projects. Harold Johnson presented an overview of LAX's Landside Access Modernization Program (LAMP). LAMP's four primary components include the automated people mover system, the consoliadated rental car facility, the intermodal transportation facilities and the traffic and roadway improvements. Johnson fielded audience questions about the project and minority contracting issues.

Top ranked online hospitality provider Airbnb presented its latest product, Experiences, at the June GLAAACC in the AM networking mixer. Airbnb Southern California Policy Manager John Choi and his team presented an overview of Experience which provides travelers as well as locals the ability to book unique experiences with community experts and locals, encompassing activities from hikes to the Hollywood sign, special behind the scenes tours and lessons in community gardening followed by a four-course meal.

Airbnb is looking for Experience Hosts — including business owners — who can provide unique access to their communities from a local perspective. Airbnb experiences can be reserved by anyone but can only be accessed through Airbnb's online marketplace.

Experience hosts receive 80% of their revenue and set their own schedule and prices. Airbnb will waive their 20% fee for non-profit Experience hosts, allowing them to retain 100% of the revenues. Questions can be directed to: LATrips@airbnb.com and Maria.c@airbnb.com.
